

## Patinoire Kockelscheuer during COVID

### C) PUBLIC

#### **1. Period for duration of the derogations**

This applies for the COVID period until an official (government or VdL) decision is taken that no special protection measures are necessary.

#### **2. Rules Basis**

The national Covid19 law and the temporary health recommendations of the Health Authority currently in force is the regulatory basis. Laws and rules that apply in other countries, ice rinks, sports arenas, were also consulted as well to define the best possible compromise.

#### **3. Whom do the rules concern**

The following rules apply without exception to all users of the Kockelscheuer ice rink. Every person visiting the infrastructure of the Kockelscheuer Ice Rink accepts and abides by the rules when entering the area.

#### **4. Where are the rules applied**

The rules apply to the entire infrastructure inside and outside the Kockelscheuer ice rink. This includes the entire outdoor area, the multisport training area, the access between the buildings, the square in front of the building with queues, the cafeteria terrace

#### **5. Public**

##### **5.1. Public skating during COVID**

Anyone can visit the ice rink during the opening hours according to Covid's rules.

It is not necessary to make a reservation in advance.

There are no temporary limits.

##### **5.2. Number of visitors**

Due to the current legal situation and rules, the capacity of the public ice rink is 500 persons.

##### **5.3. Saison de la patinoire**

The public ice rink is open to the public from 15 September to 15 April.

##### **5.4. Opening hours**

The opening hours are published at the entrance of the rink as well as on website of the rink.

## **5.5. COVID rules for rink visitors**

The generally known Covid rules are the basis for every rink visitor.

The Kockelscheuer ice rink is operated on the basis of the CovidCheck rules.

According to these rules, anyone is allowed to move around the CovidCheck area without a mask and without distance rules. Every visitor is free to wear a mask.

Gel dispensers are installed and instructions on proper hand washing are posted next to the washbasins.

For reasons of hygiene, visitors are asked not to share, exchange or borrow equipment, clothes, drinks, etc. between themselves.

In order to avoid the spread of the virus, it is recommended to avoid the formation of gatherings.

Everyone should be aware that people who can transmit the virus asymptotically may also be present at meetings.

### **5.5.1 Responsibility**

The person who visits the ice rink undertakes to accept and apply both the house rules and the Covid rules.

The instructions of the personnel must be followed without fail.

If it is found that the rules are not being followed, the person, a group, a family can be banned from the building.

This prohibition can be valid up to a whole season.

### **5.5.2 CovidCheck**

Access to the public ice rink is managed by CovidCheck for public passage.

Access to the building is only possible through the main entrance.

All other doors remain locked from the outside.

The entire interior area is therefore considered a CovidCheck area.

The rule is that anyone leaving the building must pass through the CovidCheck again before re-entering the building.

Only people who are not at risk of transmitting the Corona virus are allowed to enter the building.

To check this, the 3G rule is applied: Vaccinated, tested or cured.

In addition, if permitted by law, a paid rapid test can be carried out before entering the building.

This must be negative before access is possible.

Children under 6 years of age do not need to be tested.

All persons from 6 years of age must be able to identify themselves as Corona negative according to the 3G rule (QR code, PCR test, certified rapid test) or, as a possible option, be tested on site.

### 5.5.3 Guidance

To regulate the flow of visitors, they are divided into 2 groups in front of the main entrance by means of a grid guidance system.

Visitors with a QR code are guided to an entrance door and checked on the spot via an application.

If access is approved, the visitor can enter the building.

Visitors without a QR code will first be directed to counter 1 where they will be offered a quick test which the visitor must complete himself.

The visitor leaves the quick test with the employee, receives a number and goes to a specially installed waiting tent for 15 minutes. After the appropriate waiting time, the tested visitor goes to counter 2 and, depending on the result of the quick test, is granted or denied access.

If access is granted, the visitor is directed to an entrance door and allowed to enter.

Some of the traffic lanes are designed as one-way streets and are marked accordingly.

Persons wishing to leave the building should use the exit marked accordingly.

Sports changing rooms and showers are not accessible to the public.

### 5.5.4 Lockers

700 lockers are available for the storage of personal belongings, as well as visitors' shoes.

Access to this area is from the turnstile side.

Once you have left this area towards the ice rink, you must use the exit from the ice rink towards the entrance hall to return to this area.

This area should not be used as a rest room or for group training. The stay in this area should be as short as possible.

### 5.5.5 Wearing mask

Masks are required outside the building until the 3G test has been completed.

If the corona test is negative, you may enter the building without a mask. If not, you are not allowed to enter the building and must take the prescribed protective measures and perform a PCR test as soon as possible.

## 5.5.6 Desinfection

In addition to the normal wash basins with soap in the sanitary rooms, gel dispensers with disinfection gel are installed in the ice rink for use by visitors. 2 gel dispensers are located directly at the entrance doors, where arriving visitors are asked to disinfect their hands before entering the building.

One gel dispenser is located at the entrance to the changing room

One gel dispenser is located next to the exit between the ice rink and the entrance hall.

One gel dispenser is located at the entrance to the rink in the area of the skating school.

One gel dispenser is installed in the first aid room

Skates, helmets and penguins are disinfected, both when they are handed in and when they are taken out.

In addition to the daily cleaning by the cleaning team, the contact surfaces (cash machines, door handles, sanitary facilities, ...) are regularly disinfected during the day by the rink staff.
