

Patinoire Kockelscheuer during COVID

C) PUBLIC

1. Period for duration of the derogations

This applies for the COVID period until an official (government or VdL) decision is taken that no special protection measures are necessary.

2. Rules Basis

The national Covid19 law is the regulatory basis. Laws and rules that apply in other countries, ice rinks, sports arenas, were also consulted as well to define the best possible compromise.

3. Whom do the rules concern

The following rules apply without exception to all users of the Kockelscheuer ice rink. Every person visiting the infrastructure of the Kockelscheuer Ice Rink accepts and abides by the rules when entering the area.

4. Where are the rules applied

The rules apply to the entire infrastructure inside and outside the Kockelscheuer ice rink. This includes the entire outdoor area, the multisport training area, the access between the buildings, the square in front of the building with queues, the cafeteria terrace

5. Public

5.1. Public skating during COVID

Any person can visit the ice rink according to the Covid rules.
Advance booking is not necessary.
No personal data is collected.

5.2. Number of visitors

Due to the distance rules and the usable area, the number of visitors is limited to 450 persons at the public rink.

5.3. Opening hours

The opening hours are published at the entrance of the rink as well as on website of the rink.

5.4. COVID rules for rink visitors

The generally known Covid rules form the basis for every visitor to the ice rink.

Keep distance, mask obligation, hygiene rules.

Furthermore, running directions are given in the building, gel dispensers are set up, and instructions on how to wash hands properly are hung next to the wash basins.

For reasons of hygiene, visitors are urgently requested not to share gear, clothes, drinks, etc... to exchange or lend among themselves.

These rules apply to indoor activities to prevent the formation of clusters and further spread of the virus.

Everyone must be aware that when people meet, there may also be people present who can pass on the virus asymptotically.

5.4.1 Responsibility

The person who visits the ice rink undertakes to accept and apply both the house rules and the Covid rules.

The instructions of the personnel must be followed without fail.

If it is found that the rules are not being followed, the person, a group, a family can be banned from the building.

This prohibition can be valid up to a whole season.

5.4.2 Obligation to wear a mask

On the basis of the Covid Act of 17 July 2020, as well as the amendment of 24 July 2020, the entire interior of the building, as well as **ON THE ICE**, is subject to compulsory masking without exception.

Excluded are children under 6 years of age.

In addition to the obligatory wearing of a mask, it is recommended to the visitors to wear gloves during their stay.

5.4.3 Access to the ice rink

To prevent people from gathering when entering the building and to control the movements of visitors in the building, signs and guidance were installed.

To make the rules of distance easier to apply, both indoors and outdoors, there are markings on the floor indicating where to wait.

5.4.4 Circulation within the building

Markings indicate the direction of movement in the building.

The entrance and exit to the changing room is one-way.

Access to the changing room is from the side of the turnstile.

If you have left the changing room in the direction of the ice rink you have to use the exit from the rink to the entrance hall to get back to the changing room.

The changing room may not be used as a rest room or for group formation.

The stay in the changing room should be as short as possible. The room can be used for 50 people at a time. If the number is reached, the turnstile can be closed for a short time.

5.4.5 Desinfection

In addition to the normal wash basins with soap in the sanitary rooms, gel dispensers with disinfection gel are installed in the ice rink for use by visitors.

2 gel dispensers are located directly at the entrance doors, where arriving visitors are asked to disinfect their hands before entering the building.

One gel dispenser is located at the entrance to the changing room

One gel dispenser is located next to the exit between the ice rink and the entrance hall.

One gel dispenser is located at the entrance to the rink in the area of the skating school.

One gel dispenser is installed in the first aid room

Skates, helmets and penguins are disinfected, both when they are handed in and when they are taken out.

In addition to the daily cleaning by the cleaning team, the contact surfaces (cash machines, door handles, sanitary facilities, ...) are regularly disinfected during the day by the rink staff.
