The exhibition "War & Freedom", which will take place within MAMER 2019, is written out for collections with emphasis on war and on freedom. Participation is open to:

- members affiliated with the FSPL associations;

- collectors from abroad invited by the organizer

The responsible organiser is the Cercle Philatélique Mamer, member of the FSPL (Fédération des Sociétés Philatéliques du Grand-Duché de Luxembourg).

The exhibition takes place in Mamer /Luxembourg /Europe, on Saturday 12th and Sunday 13th of October 2019.

4. The registrations on the special entry form have to be sent up to the 1st of May 2019 directly to the exhibition director, Ralph LETSCH, 2 rue Spierzelt, L-8063 Bertrange (or rletsch@pt.lu).

The exhibitors are selected by the organizer up to the 1st of June 2019. Each exhibitor has the right to at the most five exhibition frames of (12 or) 15 sheets.

6.

The collections will not be evaluated.

7.

The collections should nevertheless not contain any items which are in contradiction to the regulations of the FIP on harmful or unwanted emissions.

8.

Each exhibitor will receive a special price, as well as a diploma.

9

Only sheets which are to be exposed can be accepted. Each sheet must be provided with a transparent sleeve.

10. No writing and participation fee are levied.

11.

The exhibitor himself ensures that his exhibit is brought in time for the exhibition and set up. The exhibitor is also obliged to take back the exhibit after the end of the exhibition; on request, the dismantling and the delivery by post to the exhibitor is done by the organizer by pre-paid contribution of EUR 30, -.

The exhibitors themselves have to take care of all risks in order to insure their collection. The organizer provides for the best possible protection of the collections, but rejects any responsibility for loss, damage and theft; either in part or in full, during the transportation, the construction, the duration of the exhibition and the dismantling of the collections. 13.

In all cases, which are not foreseen by the present regulation, the organisation executive committee decides.

The signature of the exhibitor on the special entry form for registration means the recognition and the observance of these regulations.
